



Paysend Summer Referral Bonus 2026 Promotion Terms and Conditions

These Paysend Summer Referral Bonus 2026 Promotion Terms and Conditions ("**Special Referral Terms**") apply to eligible Paysend customers ("**Customer**", "**you**", "**your**")

By taking part in this Paysend Summer Referral Bonus 2026 Promotion ("**Promotion**"), you are deemed to have accepted and agreed to be bound by these Promotion Terms and by any other requirements set out in related promotional materials issued by Paysend ("**Paysend**", "**our**", "**we**", "**us**"). These Promotion Terms are supplemental to, and must be read together with, the Paysend Terms of Service applicable to your jurisdiction, and the Standard Marketing Terms and Conditions, both available at <https://paysend.com/rules> (collectively defined as the "**Promotion Terms**").

Eligibility Requirements:

To qualify for the Promotion, you must:

1. Be a registered Paysend customer;
2. Be a resident of the United Kingdom (UK), European Economic Area (EEA), Canada (CAN) or Australia (AUS);
3. Be at least 18 years old or the applicable age of consent in your jurisdiction;
4. Be referred to use Paysend through our Rewards Program/Refer a Friend Program (applicable for new Referrals as defined below); and
5. During the Promotion Period, comply with all promotional requirements set forth in these terms and any other applicable promotional communications.

Promotion period:

The Promotion will run from June 1, 2026, through July 31, 2026 ("**Promotion Period**").

Promotion:

1. During the Promotion Period, eligible customers who participate in the "Refer a Friend Rewards Program" in accordance with Clause 4 of the Standard Marketing Terms and Conditions:
 - a. Shall be eligible to earn additional bonus rewards in addition to any standard bonuses (set out Clause 4(d)(iv) of the Standard Marketing Terms and Conditions) otherwise available under the program, subject to the following:
 - i) \$50 USD (or equivalent) bonus rewards if they successfully complete a minimum of three (3) Qualified Referrals (as defined below).
 - ii) \$100 USD (or equivalent) bonus rewards if they successfully complete a minimum of five (5) Qualified Referrals.
 - iii) \$250 USD (or equivalent) bonus rewards if they successfully complete a minimum of ten (10) Qualified Referrals.
 - b. "**Qualified Referral**" means a New Customer (as defined in the Standard Marketing Terms and Conditions) who successfully completes an international transfer totalling \$100 USD (or currency equivalent) or more during the Promotion Period, whether in a single transfer or across multiple transfers.
 - c. Any applicable bonus rewards earned under this Promotion will be credited to the customers Paysend bonus account within 14 working days from the Promotional Period and following satisfaction of the applicable criteria set out above.
2. The eligible New Customer who during the Promotion Period:

- a) Successfully completes their first international money transfer to any country supported by Paysend will have the standard Paysend transaction fee waived for that transfer. Third-party fees may still apply.
- b) Successfully completes their second international money transfer to any country supported by Paysend of at least \$100 USD (or equivalent), will receive a \$5 USD bonus in their Paysend bonus account. The bonus will be credited to the sender's Paysend bonus account within 24 hours of successful transaction completion.

General Conditions Applicable to all Promotions

- 1) The Promotion cannot be combined with other promotions.
- 2) A transfer is considered 'successfully completed' when the funds are deposited into your intended recipient's bank account, credited to your recipient's eligible debit card, deposited into a supported mobile wallet (where available), or collected by your recipient at a designated cash pick-up location. Insufficient funding of your transfer will render you ineligible for the Promotion. The Promotion will not apply to any otherwise qualifying transaction that is cancelled by you or by Paysend.
- 3) These promotions do not apply to same currency transfers.
- 4) Third party fees may still apply.

Other Important Information:

1. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods, will void and disqualify the customer from receiving the Promotion at Paysend's sole discretion.
2. The promotion is non-transferable and cannot be redeemed, refunded, re-sold or exchanged for cash. Our standard terms and conditions which you agreed to when you registered with us (or any subsequent updates) apply and can be found on our website or mobile app and platform.
3. We reserve the right to change these Promotion Terms at any time and in our sole discretion without notice to you, as allowed under applicable laws. Any qualifying transfer will be honored if initiated prior to the Promotion's cancellation.

Paysend reserves the right to void the Promotion, or individual transfers, if transfers appear to be fraudulent or are not compliant with our Terms of Service applicable to your jurisdiction available at: <https://paysend.com/rules>. Paysend reserves the right to disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive.
5. If you are entitled to any refund, you will not be entitled to receive any amount greater than the amount you have paid to make the money transfer. Please be aware that foreign currency exchange rates are subject to change.
6. TO THE FULLEST EXTENT PERMITTED BY LAW, PAYSEND SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES ARISING OUT OF OR RELATED TO THIS PROMOTION, INCLUDING BUT NOT LIMITED TO LOST PROFITS OR LOST DATA
7. You may not participate in the Promotion where doing so would be prohibited by any applicable law, statute, or regulations.

9. If any part/s of these Promotion Terms are legally ruled to be invalid, illegal or unenforceable, the remainder will not be affected and will continue in full force and effect.

Any translation of these Promotion Terms is for courtesy only and if there is a difference in interpretation between the English text and the other language text, the English text interpretation will prevail. Any dispute arising in relation to the same shall be governed by the laws of England and Wales and the courts of England shall have exclusive jurisdiction over any such disputes.
