

24 Days of Christmas Giveaway Poland Full Terms and Conditions

- By participating in the 24 Days of Christmas Giveaway Poland "Giveaway", you agree to be bound by these terms and conditions "Terms" and any additional requirements outlined in related promotional materials, including any additional specific terms and conditions applicable to such promotion. These Terms are supplemental to, and must be read in conjunction with, the Paysend Terms of Service applicable to your jurisdiction and the Standard Marketing Terms and Conditions, both available at: https://paysend.com/rules.
- 2. The Giveaway is only open to residents of Poland, aged 18 or over at the time of the Giveaway, excluding employees, and their immediate families, of the Promoter or any company affiliated with the Promoter, their agents or any other persons professionally connected with the Giveaway.
- 3. The Giveaway opens at 00:00 CET on 1st December 2025 and closes at 23:59 CET on 24th December 2025 ("**Promotion Period**"). Entries received outside this period will not be considered.
- 4. **To Enter:** Eligible entrants residing in Poland, will automatically qualify for entry into the Promotion during the Promotion Period, if they have fulfilled the following criteria:
 - a) Hold a valid, registered Paysend account, or successfully register for a Paysend account during the Promotion Period;
 - b) Participate in the Paysend "Refer a Friend" rewards program by referring a friend or family member to send money using Paysend in accordance with the program's terms and conditions found under our Standard Marketing Terms and Conditions; and
 - c) Ensure that the referred individual registers for a Paysend account.

Each successful referral completed in accordance with these requirements and the requirements set out under our Standard Marketing Terms and Conditions will constitute one (1) valid entry into the Promotion.

- 8. **Prize Details and Conditions:** The bonus will be credited to the winner's Paysend bonus account. The winner must ensure that they have an active Paysend account to receive the Prize.

- 10. Winner Notification: The winners will be notified via email and will be asked to provide evidence of identity and eligibility. Reasonable efforts will be made to contact the winners. Winners will then have 2 business days to respond and confirm acceptance of the Prize. If the winners do not respond to the Promoter within this time, they will forfeit their Prize, and the Promoter shall select another winner at random from all remaining valid entries.
- 11. The Giveaway is not sponsored, endorsed or administrated by Instagram or Facebook.

- 12. By participating in this Giveaway, you confirm that you understand that the Prize or any other reward may be subject to local income tax in the country of your residence and/or in the local territory where you are a tax resident. It is your responsibility to pay any tax which may arise from receiving the Prize or any other reward.  - Disqualify entries made using anonymous email services such as, but not limited to, GuerillaMail, Dispostable or Mailinator.
